## *A List of Topical Resources at the Chatham Square Branch Library*

**Primary sources** are created by people who witnessed or participated in an event and recorded it during or immediately afterwards. Some examples are manuscripts, contemporary records or documents, letters, photographs, interviews, historical records, maps and personal papers.

**Secondary sources** describe, summarize, analyze, evaluate, derive from, or are based on primary source material. For example, a review, critical analysis, second-hand account, or biographical or historical study.

### *World History Online*

Covers the important civilizations and cultures of world history from prehistoric times through the modern era. Topical entries, biographies, maps, primary source documents, and timelines provide a detailed and comparative view of the people, places, and events that have defined world history.

### *American Women's History*

Provides direct access to thousand of entries—biographies, historical and topical entries, speeches, maps, timelines, tables and charts, primary sources, and photographs—that are essential to understanding the experiences of American women throughout our nation's history.

### *American Indian History and Culture*

Covering more than 5,000 years of culture, legends, and leaders of over 500 Native American groups, this database provides entries on primary source documents, biographies, maps & charts, images, and timelines. It also features searchable tribe and culture area indexes, as well as the ability to search for tribes by region.

### *Ancient History and Culture*

This database provides a balanced, global view of the ancient world as it explores six ancient centers of civilization—Africa, Egypt, Greece, Rome, Mesoamerica, and Mesopotamia, spanning the period from the early Hominids 3 to 5 million years ago through 1522 CE.
